Equipment is to be returned to Rockin' River Adventures LLC by 6 pm on the final date of the rental unless other arrangements are made in advance. Lessee agrees to pay Rockin' River Adventures LLC \$10.00 for late return on final day of the lease.

In consideration of this lease and the following mutual covenants and agreements, lessee agrees as follows:

- a. He/she will take precautions to safeguard all equipment
- b. He/she accepts full responsibility for the equipment and agrees to return the equipment to lessor on the date agreed upon in as good condition as when received.
- c. He/she shall indemnify the lessor against all loss and damage to equipment covered by this agreement and agrees to pay the lessor any amounts owed to lessor by virtue of said indemnification within one week from the date loss or damage occurs. The replacement value for the most common types of loss or damage is agreed to be as follows:

1. Kayak lost or stolen: list price of kayak	5. Broken strap on kayak: \$25
2. Hole in Kayak: \$150	6. Bow/stern damage: \$100
3. Lost or damaged kayak paddle: \$40	7. Large gouges in kayak: \$20
4. Lost or damaged life vest: \$20	
- d. He/she shall indemnify the lessor against and hold it harmless from any and all claims, demands, lawsuits and causes of action for personal injuries (including death) or for property damage arising out of the use, operation, transportation or possession of said equipment.
- e. That the kayak shall be taken only on the waters indicated herein, and that life vests (PFDs) will be worn by all paddlers while on water.
- f. He/she will not stop payment on any checks or credit cards used for rental of kayaks or equipment.
- g. That he/she has read the map of the section of river he/she will paddle.
- h. That he/she will limit whitewater trips to two persons per canoe.
- i. That he/she will comply with all Federal, State and County laws and regulations of other governmental agencies including any emergency orders from authorities as to water controls and/or Forest controls relating to fires.
- j. That each kayak will be carried to and removed from the water by Rockin' River Adventures personnel (Catawba River only- does not apply to rentals that are dispatched to other areas).
